 - No child shall be subjected to physical punishment or mental harassment. ii.
 - No child is required to pass any board examination till the completion of III. elementary education.
 - Every child completing elementary education shall be awarded a certificate as iV. laid down under Rule 22.
 - Inclusion of Students with disabilities/ special needs as per provision of the Act. ٧. The teachers are recruited with minimum qualification as laid under Section-23 (1) of the Act.

The teacher performs its duties specified under Section 24(1) of the Act and The teachers shall not engage themselves for private teaching activities.

The School shall follow the syllabus on the basis of curriculum laid down by appropriate Shym Vifosyst authority.
