No Financial Assistance and Grant-in-Aid (both recurring & non-recurring) will be claimed by the institution from the Government at any point of time for meeting the salary cost and its component towards teaching and non-teaching staff appointed by the Managing Committee for meeting any other expenses for managing the school.
- 4. The High Power Committee shall be competent to review the NOC granted to the Institution concerned and shall be competent to withdraw the same if any of the terms and conditions contained in G.O No.30720/SME dtd.23.9.96 and No.29519/SME dtd.26.9.98 read with G.O No.10011/SME dtd.11.6.2004 is/are violated at any time.
- The Managing Committee shall be constituted in accordance with the Sec-7 of the Orissa Education Act-1969.
- The Managing Committee of the school will not shift the present location of the school without prior approval of Director, Secondary Education, Odisha.
- 7. The Managing Committee shall ensure the continuity of all eligibility criteria for Grant of NOC. If any deterioration from present status of the school is detected at any point of time then the NOC shall be withdrawn.
- The school authority shall apply in the prescribed form for NOC on or before 15th
 January of the year with the prescribed fee.
- 9. If at any point of time it is found that information submitted by the school is not in conformity with the field position, appropriate legal action against the school authority will be initiated besides withdrawal of NOC.
- The school is stipulated to fulfil the deficiencies (given below) within a period of one year.
