Location: The Registered Office of the Society

A. Address: Dibya Prasad Aradhana Society, Sneha Sadan convent
Gaddeulia, Mayurbhanj Dt, Odisha, India, 757082.

B. Area of operation: The area of operation shall be the state of Odisha.

Aims and objectives:

1. It aims at the service of the society with an emphasis for the benefit of the needy communities irrespective of caste, class, creed and sects. And the main objective is the holistic development of women and children particularly.

2. To perform works of charity by providing educational, medical, health care services for the betterment of the downtrodden.

3. To do religious and social services and to do everything for the education and the training of youth for the pursuit of science and the diffusion of the social, moral, cultural, religious and secular knowledge and values, and to inculcate or instill such spirit, wisdom and confidence especially in the minds of the youth.

4. To establish, administer and supervise educational, social, religious and training institutions and to acquire or possess the necessary and required Infrastructure and also to act as a Central Body for all such Institutions of this Society or coming under or brought this D.P.A.S. All educational institutions established and administered by Dibya Prasad Aradhana Society are minority institutions covered under article 30(1) of the Constitution of India primarily for the benefit of Christians. However, admissions in these minority educational institutions shall be given to others as well, irrespective of caste, creed, colour and sex.
